

WARRANTY

We want you to be happy with your cabinets purchase from **BEST CABINET & GRANITE SUPPLY INC.**, so we stand behind every one with our Warranty.

Lifetime Limited Warranty

Best Cabinet & Granite Supply INC hereby warrants to the original purchaser, for residential applications only, that all cabinets and accessories are free from defects in materials and workmanship. This warranty runs for as long as you own your home and begins upon the date of delivery to you. This warranty is expressly limited to repair or replacement of the defective part at the discretion of Best Cabinet & Granite Supply INC., and does not include labor for removal or replacement. This warranty does not extend to defects caused by improper handling, storage, installation, assembly or dis-assembly, intentional damage, product modifications, exposure to the elements including humidity which may result in warping or splitting, accidental misuse, abuse or negligence.

Natural woods may vary in texture, color and wood grain, and exhibit subtle changes as they age. For example, wood joint may eventually have visible cracking around the joint area and cabinet colors may darken or lighten over time. Sunlight, smoke, moisture, household cleaners and other environmental conditions may cause materials to vary from their original color and/or to warp, split or crack. These variations are considered to be the nature of the material in relation to their environmental exposure and are not covered under this warranty.

("the manufacturer") warrants the original consumer purchaser for as long as they own their home that their Best Cabinet & Granite Supply INC Cabinetry products will be free from defects in material and workmanship under normal use. This warranty is only applicable to products used in residential applications within the United States and is not transferable to subsequent owners. Should defects in material or workmanship exist during the applicable warranty period in any Best Cabinet & Granite Supply INC Cabinetry product, the manufacturer will elect at its discretion to either repair or replace the defective material or component, free of charge. This warranty covers only parts and materials of the products supplied by the manufacturer. Not covered under this warranty are counter tops, appliances, plumbing fixtures, etc. or the costs, including labor, to remove and reinstall materials and related components such as fittings, appliances, etc. This warranty shall become void if the cabinets are in any way modified, improperly installed or damaged prior to or during the installation. Furthermore, this warranty will not apply cabinets damaged by misuse, neglect, abuse, acts of God, exposure to extreme temperatures or the effects of normal wear and tear.

THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR PURPOSE ARE LIMITED IN DURATION TO THE LENGTH OF THE LIMITED WARRANTY PERIOD. THE LIMITED WARRANTIES SET FORTH HEREIN ARE LIMITED TO THE FIRST AND ORIGINAL BUYER AND ARE NOT TRANSFERABLE THEREAFTER. IN NO EVENT SHALL BEST CABINET &
